  a photocopy of the table of contents, if available.

2. If you are submitting a new ISBN for a title already on file, you do not have to include support material.

Editors must identify their written contribution (including the number of pages) on the photocopy of the table of contents. This year, you may register titles published between January 1, 2016 and May 1, 2021.

## DO I NEED TO SEND IN THE FILE UPDATE FORM?

If you have no new titles, new editions or new versions to add to your file, you do not need to return this form.

## **HOW DO I ADD TITLES TO MY PLR FILE?**

To register an audiobook, you must use the Audiobook Registration form available online. (https://publiclendingright.ca/update-your-file/register-new-title)

Consult the eligibility criteria below to make sure that you and your titles are eligible before you fill out the File Update form.

Include the necessary support material with your submission.

#### DEADLINE

Registrations mailed after May 1 (with the postmark date as proof) will not be accepted and will be mailed back to you.

#### **ESTATES**

No claim may be made on behalf of a deceased author by the estate or survivors. Moreover, the shares of ineligible or deceased contributors do not accrue to the eligible or surviving contributors.

## **ELIGIBLE CREATORS**

- Writer
- Translator
- Illustrator or photographer
- Narrator
- Editor (note: only editors with original written contributions qualify)

There can be no more than six contributors to the book (this excludes editors and translators, but includes illustrators, photographers and narrators).

Your name appears on a given work's title page or copyright page or, for an anthology contributor, in the table of contents.

Your contribution to the book comprises at least 10% of the length of the book.

## **ELIGIBLE BOOKS**

Eligible genres include works of poetry, fiction, drama, children's literature, non-fiction or scholarly work.

Your book has been published in the last 5 years.

Your title must be a print book, e-book or an audiobook and have a valid ISBN.

Your book must be at least 48 pages long (24 for a children's book). For e-books, the page count is based on the PDF version.

## **HOW TO CALCULATE YOUR PERCENTAGE SHARE?**

For print and e-books, your percentage share claim is based on your specific printed contribution to the book. For example, if a 100-page book consists of 70 pages of a writer's work and 30 pages of an illustrator's work, the writer would claim 70% and the illustrator would claim 30%.

The percentage share is calculated as follows:

#### **AUTHORS OR CO-AUTHORS**

- If you are the sole creator of a book, you may claim 100%. If your book is an adaptation, you may claim 50%.
- If your book has been translated, or is available in audio format, you may claim up to 50% for each translated or narrated version. You must register each version separately.
- If you are a co-author, calculate your share according to the size of your contribution.

#### **TRANSLATORS**

- You may claim up to 50%.
- For children's picture books (24-32 pages), you may claim 33%.
- For audiobooks, you may claim 33%.
- If more than one translator is involved, the translator percentage claim must be shared accordingly.

#### **ILLUSTRATORS OR PHOTOGRAPHERS**

- Your percentage share depends on the space your photos or illustrations take up in the book.
- For children's picture books (24-32 pages), you may claim 50%, or 33% if a translator also worked on the project.

#### **NARRATORS**

- You may claim up to 50%.
- For translated audiobooks, you may claim 33%.
- If more than one narrator is involved, the narrator percentage claim must be shared accordingly.

## **EDITORS WITH ORIGINAL WRITTEN MATERIAL**

- You must have contributed original written work that is at least 10 pages and 10% of the book's text. This can be a preface, an afterword, notes on the text or another written contribution in the body of the book. The work must be identified as yours in the table of contents. Notes on the contributors, indices, timelines, glossaries, bibliographies or tables of contents do not count.
- Your name must be on the title page or copyright page.
- You must be the sole editor or one of two co-editors.
- If you are the sole editor, you may claim 20%. If two editors are involved, each may claim 10%.

### **INELIGIBLE GENRES**

The following books are not eligible in the PLR program:

- a practical book giving advice or instructions, a self-help or "how-to" book, a manual or guidebook on any subject (e.g. travel, nature, cookbook, etc.).
- a professional guide (legal, technical, medical, scientific, pedagogical, accounting, financial).
- a book designed primarily for an educational market.
- a list of any kind or short segments of information brought together in a list format (directory, index, compilation, bibliography, dictionary, atlas, encyclopedia, genealogy, etc.).
- · a book resulting from a conference, seminar or symposium.
- · the catalogue of an exhibition.
- · a newspaper, magazine or periodical.
- · an unpublished work (e.g. thesis, manuscript).
- DVD or podcast.
- as a new title: a second or subsequent edition of an eligible book, unless at least 50% of this edition constitutes completely new text, not revised text.
- · a report, survey or program evaluation.
- a title prepared for or published by a governmental or paragovernmental organization, institution or corporation.
- wholly or mainly a musical score.
- a calendar, agenda, colouring book, quiz book or game.
- · a book created for your employer in the course of your employment.
